PRESS RELEASE

The State Election Commission is announcing the revised schedule for the conduct of elections to the five Municipalities and ten Commune Panchayats in the UT of Puducherry in compliance with the orders dated 05.10.2021 of the Hon. High Court of Madras in the WP Nos. 21067, 21117 and 21708 of 2021 and WMP Nos. 22326, 22327, 22383, 22382, 22890 and 22891 of 2021. The Commission notified the allocation of reservation of seats and offices in the Municipalities and Commune Panchayats to the Scheduled Castes, Scheduled Castes Women, General Women, and General categories vide the Notifications No. 1-31/SEC/CE/Res-M/E4/2021-22/914 dated 07.10.2021 and No. 1-32/SEC/CE/Res-P/E4/2021-22/915 dated 07.10.2021 respectively.

The revised schedule for the local bodies' elections in the UT of Puducherry is as follows:

Revised Schedule of Elections

After poll for all the three phases, the Counting for all the phases will be on: 17.11.2021

The polling hours will be 7.00 A.M to 6.00 P.M with last one hour i.e., from 5.00 P.M to 6.00 P.M being ear-marked for COVID19 Patients and patients with such symptoms.

With this announcement **The Model Code of Conduct comes into force with immediate effect from today.** The Model Code of Conduct, Laws on the conduct of Local Bodies Elections and the relevant information of Electoral Rolls, Polling Stations, the contact details of DEOs, REOs, ROs, AROs and other officials of the State Election Commission are available on the Commission's website: <u>https://sec.py.gov.in</u>. State Election Commission appeal to the media, electors, candidates, and their agents/workers and all officials involved to take the COVID-19 vaccine, first or second dose as applicable, for taking part in Local Bodies Elections 2021. Further, as a precautionary measure to prevent Covid outbreaks, Commission is banning processions/road shows/street plays and cycle/bike/vehicle rallies .Public meetings and house-to-house campaigning will be allowed with strict restrictions. In addition, since these elections are at the grass-roots level, the Commission has restricted the period of campaigning to the shortest permissible by the relevant Act/Rules.

The announcement of schedule for elections to the indirect elections for the following seats: i) Vice-Chairman of the Municipalities, ii) Chairman of the Commune Panchayat Council, iii) Vice-Chairman of the Commune Panchayat Council and iv) Vice-President of the Village Panchayat in Commune Panchayats will be released after the declaration of the results of the direct elections in the Municipalities and Commune Panchayats.

The details of seats for the indirect elections, which will be held later, are as follows:

Above announcement and all further actions in the election process are in compliance with the orders of the Hon'ble Supreme Court of India, Hon'ble High Court of Madras and as per the powers vested with the State Election Commission by Articles 243 K and 243 ZA of the Constitution of India.

The Commission once again requests the cooperation of all stakeholders for the safe and smooth conduct of the civic elections.
