Local Administration - Conduct of Election to the Municipal Councils - The Puducherry Municipalities (Registration of Electors) (Amendment) Rules, 2023 - Notification - Orders - Issued.

ORDER:

The following notification shall be published in the Official Gazette of the Government of Puducherry, immediately.

NOTIFICATION

In exercise of powers conferred under clause (a) of sub-section (2) of section 65 of the Puducherry Municipalities Act, 1973 (No.9 of 1973) and all other powers enabling her in this behalf, the Lieutenant-Governor, Puducherry is hereby pleased to make the following rules further to amend the Puducherry Municipalities (Registration of Electors) Rules, 1974, namely:-

- 1. Short title, extent and commencement (1) These rules may be called the Puducherry Municipalities (Registration of Electors) (Amendments) Rules, 2023.
 - (2) They shall extent to the whole of the Union territory of Puducherry.
 - (3) They shall come into force with immediate effect.
- 2. Amendment of rule 2. In the Puducherry Municipalities (Registration of Electors) Rules, 1974, (herein after referred to as the said rules) in rule 2, after sub-rule (a), the following sub-rule shall be inserted, namely:-
 - "(aa) "Aadhaar Number" means the Unique Identification Number issued by Unique Identification Authority of India (UIDAI)."
- 3. Amendment of rule 5(6). In the said rules, in rule 5, sub-rule (6), for the words "his wife", the words "his / her spouse" shall be substituted.
- 4. Amendment of rule 5(7).- In the said rules, in rule 5, sub-rule (7), for the words "his wife", the words and figure "his / her spouse" shall be substituted.
- **5.** Amendment of rule 7(1).- In the said rules, for the word "he" the words "he/she" shall be substituted.
- **6.** Amendment of Forms 1 to 4 under rule 7 In the said rules, in rule 7, in Forms, 1,2,3, and 4 thereunder, after the words "my wife", the figure and word "husband" shall be inserted.

- 7. Amendment of rule 8.- In the said rules, in rule 8, for the existing rule, the following shall be substituted, namely:-
 - "8(1) The registration officer, if necessary may for the purpose preparing the roll; and letter of request in Form 5 to the occupants of dwelling house in the ward or any part thereof, and every person receiving any such letter shall furnish the information which may include Aadhar Number issued by the Unique Identification Authority of India."

After the existing rule 8 (1), the following sub-rules shall be inserted, namely:-

(2) The registration Officer may for the purpose of establishing the identity of any person require that such person may furnish the Aadhaar number issued by the Unique Identification Authority of India (UIDAI) as per the provisions of the Aadhaar (Targeted Delivery of Financial and Other subsidies, Benefits and Services) Act, 2016.

Provided that the registration officer may also require the Aadhaar number from persons already included in the electoral roll for the purposes of authentication of entries in electoral roll and to identify registration of name of the same person in the electoral roll of more than one constituency or more than once in the same constituency.

- (3) Every person whose name is included in the electoral roll may intimate his Aadhaar number to such authority in Form-20 appended to this rule.
- (4) No application for inclusion of name in the electoral roll shall be denied and no entries in the electoral roll shall be deleted for inability of an individual to furnish or intimate Aadhaar number due to such sufficient causes may be prescribed:

Provided that such individual may be allowed to furnish such other alternate documents as may be prescribed.

Explanation – For the purpose of this rule, the expression "Aadhaar number" shall have the same meaning as assigned to it in clause (a) of section 2 of the Aadhaar (Targeted Delivery of Financial and Other Subsidies, Benefits and Services) Act, 2016 and sub-section 8(3), 8(4) of the said Act shall apply mutatis mutandis here.

- 8. Amendment of rule 26 In the said rules, in rule 26, after sub-rule (2), the following sub-rule shall be inserted, namely:-
 - "(3) The details of Aadhaar of electors as issued by the Unique Identification Authority of India (UIDAI) may be linked with Electoral Roll by making an application in Form-20 with proof by the electors as given in rule 8 which shall apply mutatis and mutandis here.
 - (4) The details of Aadhaar or other details for identification of new applicants who submit application for inclusion of name in the Electoral roll and application for transposition of entries etc., shall also be given in the prescribed Forms 7 and 10, respectively".
- 9. Amendment of Form 7 under rule 13(1) and 27. In the said rules, in rule 13(1) and 27, for the existing Form 7, the following shall be substituted namely:-
